# WHAT ARE TRUSTEES EXPECTED TO DO?

- Take the Oath of Office in the Amherst Town Clerk's office
- File a yearly Financial disclosure form to the Town of Amherst
- Attend board meetings and participate, having reviewed agenda items and documents sent in advance
- Work to support and oversee the Amherst Library Director
- Handle matters related to budget and personnel, including fiscal quality control
- Remain up-to-date with the B&ECPL Board of Trustees and System policies
- Take on board roles as determined collaboratively with other board members
- Participate in professional development opportunities as required by state law
- Familiarize themselves with each of the four Amherst Public Library branches, their staff, services and activities
- Maintain current email and check it regularly
- Support the Library Bill of Rights and Freedom to Read



### **OUR LIBRARIES**

The Amherst Public Libraries consist of four branch libraries: Amherst Main Library at Audubon, Clearfield, Eggertsville-Snyder, and Williamsville. A contracting library within the Buffalo and Erie County Public Library system, the Amherst Public Libraries are among the region's busiest, with over 313,000 patron visits and nearly one million circulations in 2023!

## **FAQ**

What kind of time commitment is expected of Trustees?

- Regular meetings run 1 2
  hours, with approximately 10
  meetings each year.
  Preparation for meetings
  can take an additional hour
  or so each month.
- The term of office for a library trustee is five years.

What personal qualities should a Trustee possess?

- Trustees should be able to listen, work collaboratively, compromise, and engage in problem-solving. Absolute confidentiality is essential.
- Trustees or their families may not enter into a business relationship with the library, even if they are providing a service below cost.
